RRRESTED CO-DEFENDANTS

ENDANT DID THE FOLLOWING ACT(S) WHICH CONSTITUTE A VIOLATION OF THE LAW (ELEMENTS OF THE CRIME / PROBABLE CAUSE STATEMENT)

12/06/2015 AT 1551 HOURS, DEPUTIES RESPONDED TO 1322 HENDERSON CREEK DRIVE IN REFERENCE TO A DCF UNSLOR FINDING INAPPROPRIATE TEXT MESSAGES AND PHOTOGRAPHS ON THE PHONE OF A YEAR OLD JUVENILE : E CUSTODY OF THE DEPARTMENT OF CHILDREN AND FAMILIES.

HE REPORTER, DCF CASE WORKER JESSICA FORERO WAS MADE AWARE OF A POSSIBLE INAPPROPRIATE RELATIONSHIP TWEEN JUVENILE DOB AND A MENTOR FROM DCF IN FORT MYERS. THE MENTOR WAS ENTIFIED AS JO ELLEN MARIE GARDNER DOB 07/14/1983.

HE VICTIM IS CURRENTLY BEING HOUSED AT HE, GAVE HIS CELL PHONE TO A MILY MEMBER BECAUSE HE IS NOT ALLOWED TO HAVE A PHONE WHILE HOUSED AT THE DCF FACILITY.

MADE CONTACT WITH THE VICTIM'S AUNT WHO SHOWED ME THE PHONE TEXT MESSAGES BETWEEN AI RDNER. THE MESSAGES WERE THAT OF AN INTIMATE COUPLE IN CONVERSATION DETAILING SEXUAL ACTIVITIES THEY SHED TO DO TO EACH OTHER (PHONE SEX). THERE WAS ALSO PHOTOGRAPHS OF GARDNER SHOWING HER BREASTS AND HANDS HER VAGINA.

THEN SPOKE TO THE VICTIM AT AND HE ADVISED THE FOLLOWING; GARDNER IS HIS MENTOR, WHOM HE ME: ILE HE WAS HOUSED IN A TREATMENT PROGRAM IN FORT MYERS.

E ADMITTED TO HAVING INTIMATE FEELINGS FOR GARDNER, BUT DENIED HAVING ANY SEXUAL ACTIVITY. GARDNER KNOWS S AGE AND THEY HAVE NOT HAD INTERCOURSE AS OF YET.

ADMITTED TO KISSING AND HOLDING HANDS WITH GARDNER AND STATED HE DOES HAVE FEELINGS FOR HER. HE GNEED A CONSENT TO SEARCH FOR HIS CELL PHONE AND A PROPERTY RECEIPT WAS COMPLETED.

MADE CONTACT WITH SUSPECT JO ELLEN MARIE GARDNER AT HER RESIDENCE IN FORT MYERS LOCATED AT 2348 WILLARD REET. SHE AGREED TO SPEAK WITH ME AND PROVIDE A TAPED INTERVIEW.

ARDNER WAS NERVOUS AND AT FIRST DENIED ANYTHING INAPPROPRIATE BETWEEN AND HER HAD TAKEN PLACE. EN QUESTIONED, GARDNER ADVISED SHE KNOWS AGE, AND HAS NOT HAD SEXUAL RELATIONS WITH HIM. SHE MITTED TO KISSING AND HOLDING HANDS WITH , AND THAT HER DAUGHTER DOES CALL "D" NOT DADDY. RDNER ADMITTED

SHE FELT THAT SHE WAS WRONG, AND SHE ANSWERED THAT

ASKED IF SHE HAD ANY OTHER CONTACT WITH JUVENILES IN THE CUSTODY OF THE DEPARTMENT OF CHILDREN AND MILIES, SHE ADVISED ONLY ONE OTHER BOY. THE OTHER BOY IS A FRIEND OF AND GARDNER WISHED TO SEE
