 stay in my own lane. The officer
 I sat & told me to pack up and I
 was mad as hell yesterday on a Sunday
 which seem not right because they
 don't do movements on the week
 end so I ask what was going on
 he got smart so you know me
 and my mad. I got flip as hell
 but I really was asking him was
 to let me speak to the major. Then
 he said took me to the back room
 tell me I don't know shit about
 him what he do or get going on
 but I wasn't on all that. I let
 him know I'm not on all that
 type of time I could care less
 what he get going on. I'm doing
 my time. He told me to shut the
 f--- up. he was gone beat me
 to death and cross me like a
 dog. he was all in my face so I
