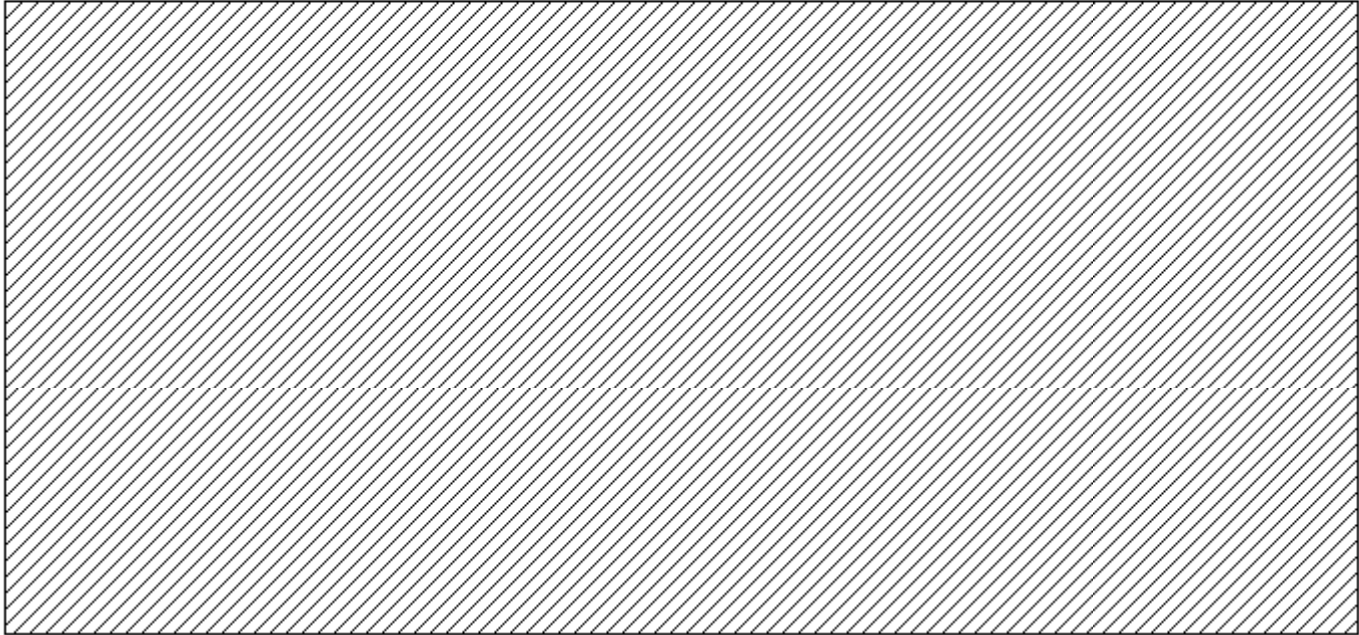

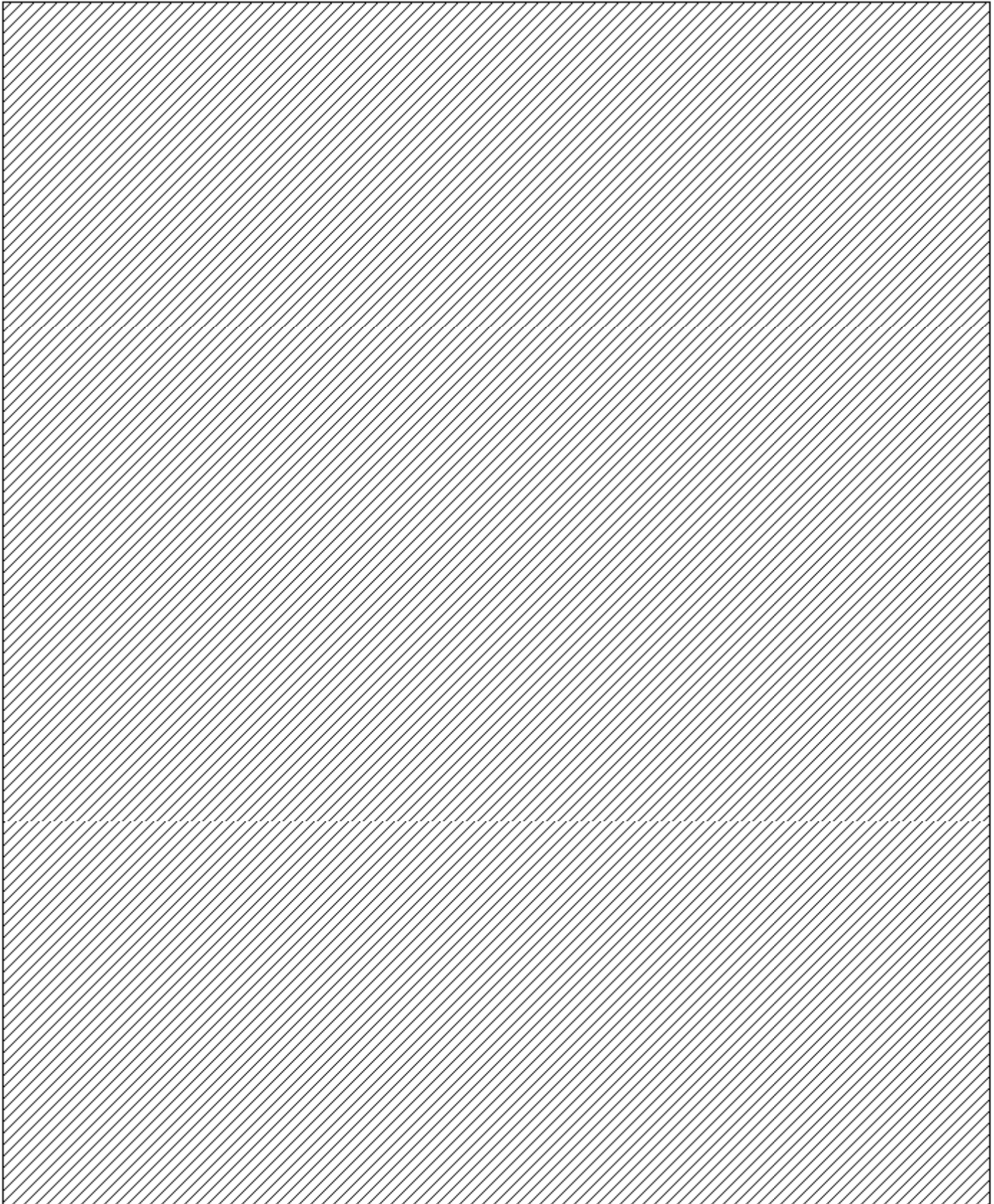
The incident below was not captured via my agency issued body camera because the battery died as soon as I arrive on scene.

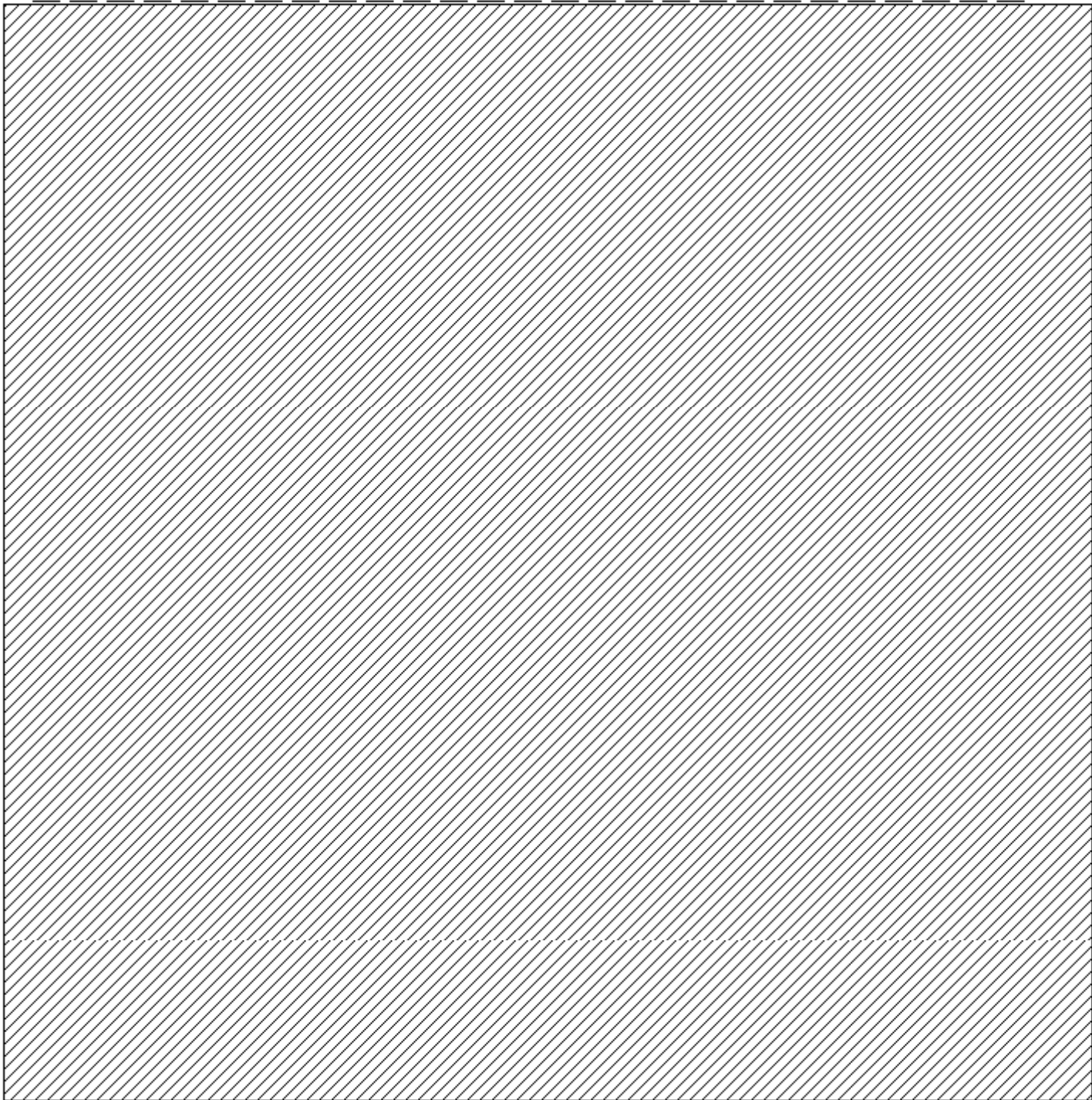
On 12/15/2016 I responded to the Florida Keys Children's Shelter, 73 High Point Rd. Plantation Key FL, Monroe County, on a report of a suicide threat. The call came out as a young female that was found hanging, however, she had been cut down.

I arrived at the shelter, shortly before rescue and went inside. I was directed by a staff member, later identified as Tasha Elliot, to where the young female was. Upon entering the room, Chief Abel from the Islamorada Fire Department was already at the scene. Chief Abel stated CPR was in progress. I then left the room and responded to the front door of the shelter so I could guide paramedics to where the victim was located. While the paramedics were working on the victim, later identified as L. Martin (d.o.b 03/06/2000), I began to interview the staff members as to what occurred.

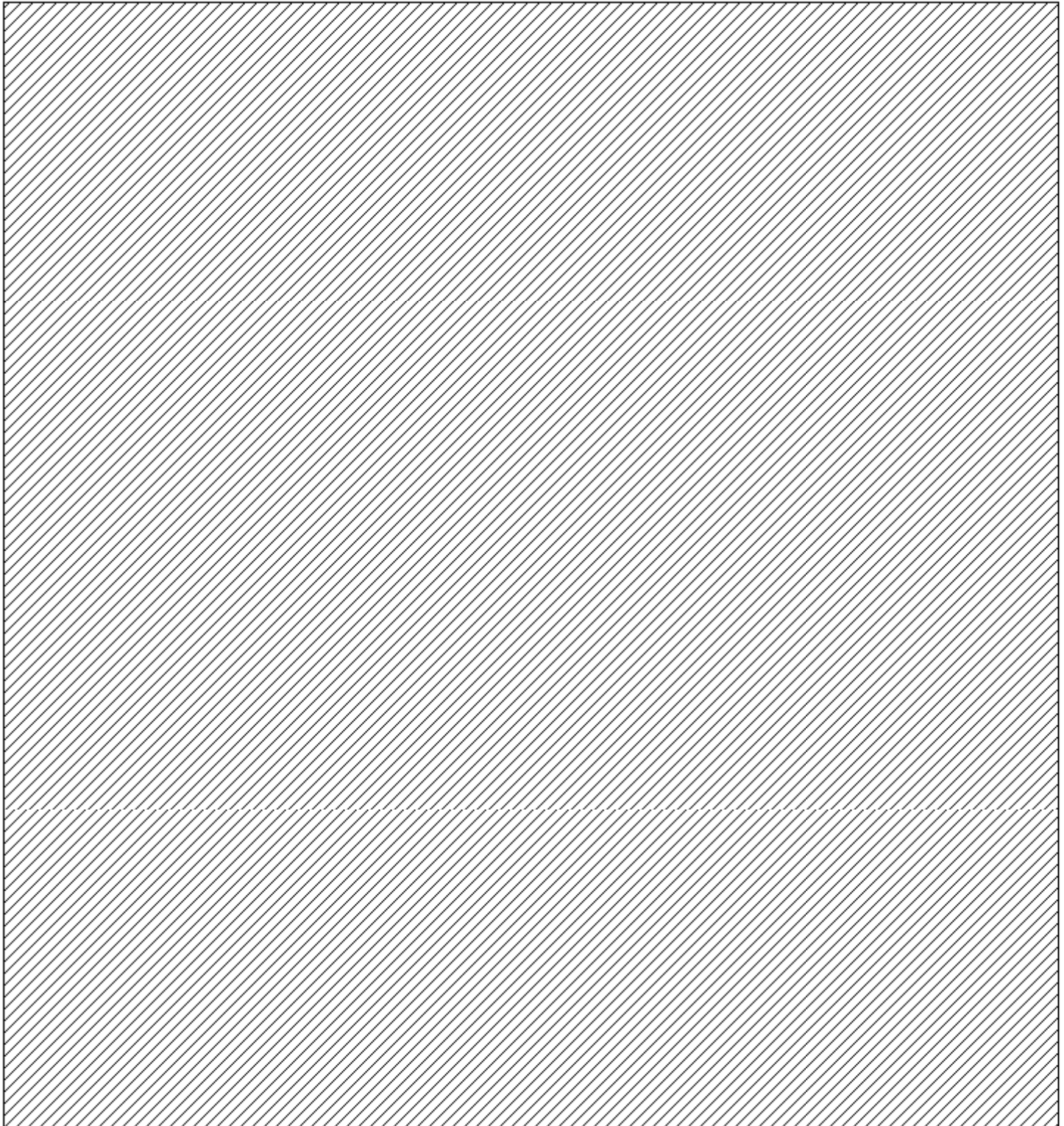
Upon speaking to [REDACTED] (juvenile who will be referred to as XB for the remainder of this report), who was the first person to find the victim in her bedroom I learned the following. [REDACTED] stated that she, the victim, and staff member Rose, were washing clothing. XB stated, staff member Rose told the victim that she needed to change her shorts, because they were too short. XB stated once the victim went to change her shorts, XB went to the common area to make a phone call. XB stated that upon the conclusion of her phone call, she went into the television room to see if the victim was there. XB stated she could not find the victim in the television room, so she went into her bedroom. XB stated that upon entering the bedroom, she noticed the victim was hanging from a door inside of the bathroom. XB stated she noticed that the victim had, what she described, as a blue or purple scarf around her neck. XB also stated there was "spit" coming out of her mouth. XB stated she did not touch the victim and immediately ran towards the common area to alert staff members of she just saw. XB stated, staff members Tasha, Steve and nurse Desire all ran towards the victims

room. XB added that she stayed behind and did not follow staff into the room.





I collected the suicide note, cell phone and file that all belonged to the victim and turned it over to Detective P. O'Keefe using PR # 155467. The scene was then turned over to Det. P. O'Keefe and I had no further involvement in this case.
